Entry Limitations: Four TD and 2 TDX tracks. Open to all breeds, who must be six months of age or older. Entries must be on an official ASCA entry form and will not be accepted without fees and signature and a statement of certification, if applicable. If the limit of entries is not reached in one test and is exceeded in the other test, the number of tracks will be exchanged on a two for one basis as described in the ASCA tracking Regulations When the limit of 4 dogs for the TD test and 2 dogs for the TDX test have been drawn, all remaining entries, subject to the conditions set forth above, shall be assigned a position on the alternate list corresponding to the order in which they are drawn. The Test Secretary shall notify all entries of the results as soon as possible.

Entries will not be accepted without proper fees and proper certification. (Tracking titles earned from other registries, on tracks of the same or greater distance and difficulty as required for an ASCA TD track can be substituted for an ASCA certification if the title has been earned on the entered dog within the last three years. A copy of the title must be

submitted with the entry.) Returned checks do not constitute a valid entry. All Returned checks are subject to an ISF fee of \$35.00.

Refunds: No entry fee will be refunded, except the entry fee of a non-participating alternate. Or in the event an accepted entry cancels after the closing date and the Secretary is able to Replace the entry from the alternate list. The entry fees will be refunded within seven days Following the Test. No entry fee will be refunded if the show cannot be opened or completed by reasons of riots, civil disturbances, fires, acts of God or public emergency.

TD and TDX entrants must be at the Test Site by 9:00 a.m. on April 4, 2010, at which time there will be a drawing for tracks for each dog entered. The first track will be run as soon thereafter as it has aged the proper length of time. In the event of absentees among the confirmed entries, the next alternate, in catalog order who is present, will be allowed to fill the vacancy. "Bitches in season may participate" according to Chapter 2, Section 8 of the ASCA tracking Regulations.

Tracking Prizes and Awards

Directions to show site:

- **From Atlanta:** take I-85N to 316 easts to Athens. In Athens, take the 'loop' Hwy 29 north to Hwy 129 North/Jefferson Highway. Go north on Hwy 129. Travel approximately 1.5 miles, turn right onto Jefferson River Rd. Travel about 3 miles, Braswell Cattle Co. on the right at 9791 Jefferson River Rd.
- **From the north:** take I85 S to Hwy 129 S. Travel 129 S through the area of 'Red Stone'. Turn left onto New Kings Bridge Road (just past brick Church on right). At 4-Way stop turn right onto Jefferson River Rd. Travel approximately 4 1/2 miles (through 4-way stop) to Braswell Cattle Company on left.
- **From Augusta:** Take Hwy 78 W to Athens. Take the 'loop'/ Hwy 29 W to N Hwy 129/Jefferson Hwy. Travel approximately 1.5 miles on Hwy 129N, and turn right onto Jefferson River Road. Travel approximately 3 miles to 9791 Jefferson River Road.
- **From Atlanta:** on I-20E take Hwy 441 to Athens. In Athens, take the 'loop' Hwy 29 north/west to Jefferson Hwy/Hwy 129 North. Travel about 1.5 miles and turn right onto Jefferson River Rd. 9791 Jefferson River Rd (Braswell Cattle Co) is about 3 miles up on the right.
